MAFI DEMURRAGE RATES & FREE TIME

Mafi demurrage for cargo on the Grimaldi Euromed service begins 4 or 5 days after the cargo discharges. Mafi demurrage is assessed for import cargo which remains loaded on the lines mafi equipment past the below noted free time. Mafi demurrage and port assessed cargo demurrage are different charges. Mafi free time may differ from the local port Cargo free time.

Should the delivery of your cargo extend beyond the mafi free time and you wish to avoid the assessment of mafi demurrage, you should coordinate with the terminal operator to discharge the freight from the mafi. Labor costs for discharging cargo from the mafi are at the expense of the cargo.

NEW YORK 4 working days free there after

Day 5 and beyond	60 MAFI	\$500.
Day 5 and beyond	all other Mafi	\$250.

BALTIMORE 5 working days free there after

Day 6 and beyond	60 MAFI	\$500.
Day 6 and beyond	all other Mafi	\$250.

JACKSONVILLE 5 working days free there after
(free time differs from terminal cargo demurrage 14 calendar days)

Day 6 and beyond	60' MAFI	\$500.
Day 6 and beyond	all other Mafi sizes	\$250.

HOUSTON 5 working days free there after
(free time differs from terminal cargo demurrage 30 days)

Day 6 thru 14	60' MAFI	\$500.
Day 6 thru 14	all other Mafi sizes	\$250.
Day 15 and beyond	60' MAFI	\$800.
Day 15 and beyond	all other Mafi sizes	\$750.
